

Tisbury Parish Council – Minutes of the Ordinary Meeting Held at 7.00 pm on Tuesday 16th July 2024 in the Reading Room, High Street, TISBURY, SP3 6LD

Questions or Statements:

An explanatory statement was made by Mr Steve McGrath regarding the additional work he had to undertake to the War Memorial wall over and above his original quote.

Wiltshire Councillor Richard Budden: Councillor Budden gave a detailed slide presentation on road safety and the incidences of injuries in the south west Wiltshire community area compared with the rest of the county. In summary, although only 4.5% of Wiltshire by population, the south west Wiltshire area accounted for 12% of those killed and seriously injured on Wiltshire roads in the three years up to the end of 2022. This reflects particularly the high proportion of roads in the area (itself a reflection of its geographic size) and of high speed through traffic on a small number of A roads.

Councillor Budden said that he would continue to request greater clarity from Wiltshire Council on why the roads in this area are so much worse than in other areas of Wiltshire and on increasing their safety.
